COMPANY NEWS

EduFocal Limited (LEARN) has advised that their Board of Directors decided on October 27, 2023, that EduFocal will seek the approval of its shareholders to pursue the subdivision of its share capital and a renounceable rights issue of ordinary shares, and that approval will be sought from shareholders at an upcoming Shareholders Meeting of the company. The Company further advises that the date, time and location of the upcoming shareholder meeting(s) will be published in short order in keeping with Company's Articles of Incorporation, the Companies Act and the requirements of the Jamaica Stock Exchange. <u>Source</u>

Seprod Limited (SEP) wishes to disclose that its subsidiary, A.S. Bryden & Sons Holdings Limited ("A.S. Bryden"), has received approval to list its ordinary and preference shares by introduction on the Main Market of the Jamaica Stock Exchange ("JSE"). By listing its shares by introduction, A.S. Bryden is not offering any new shares for sale to the public but is publicly listing all its existing ordinary and preference shares and making them available for trading. A.S. Bryden will list its ordinary and preference shares on the JSE Main Market on November 10, 2023. <u>Source</u>

NCB Financial Group (NCBFG) received shareholder approval on Tuesday to sell up to 450 million new shares to investors. It puts the potential size of the additional public offering at about \$27.8 billion based on the NCBFG stock's current market price. At the extraordinary meeting that secured the vote, NCB Financials' new management did not reveal the indicative price of the APO, which will offer 300 million units for sale to current shareholders and other stock market investors, with the option of upsizing the offer by 50 per cent to 450 million units. In fact, the banking group could raise the funds in multiple offerings over time. "To be clear we do not expect to issue the authorised shares in one punch," said NCB Financial Interim CEO Robert Almeida in response to queries at the meeting. <u>Source</u>

Jamaica Broilers Group Limited (JBG) entered six markets in the past year and is now looking towards both its regional and US segments to drive growth for the poultry company, notwithstanding logistical problems faced in exporting to new Caribbean markets. Its new markets include Cayman Islands, Turks & Caicos Islands, Anguilla, Barbados, British Virgin Islands, St Martin and St Maarten. More recently, in the first quarter, it also started exporting to Trinidad & Tobago, as disclosed on Wednesday at the company's annual general meeting. <u>Source</u>

The Margaritaville Jamaica franchise, which operates clubs and restaurants along the north coast, plans to list on the Jamaica Stock Exchange through an initial public offering of shares. The Jamaica operations include locations in Montego Bay, Negril and Ocho Rios, three resort destinations. The company has chosen Mayberry Investments Limited as its lead adviser and broker. In addition to debt reduction, the IPO proceeds will allow the company to invest in eco-friendly initiatives. <u>Source</u>

138 Student Living Jamaica Limited (138SL) has only once paid dividends to holders of its common stock since its listing nearly a decade ago, but now the company says it plans to start making regular distributions. In a statement, 138SL Chairman Ian Parsard said going forward, the company would pay half-yearly dividends "of up to 90 per cent of its distributable profits". <u>Source</u>


For the week ended November 03, 2023, the Composite Index advanced by 10.92 points (0.91%) to close at 1,190.94.


<u>S&P 500</u>

For the week ending November 03, 2023, the S&P 500 surged by 5.9%. Over the same period, the Dow Jones also declined by 5.1%, whilst the Nasdaq similarly advanced by 6.6%.

The graph below breakdown the performance of the Select Sector SPDR Exchange Traded Funds (ETFs) that represents the eleven sectors of the S&P 500 and their weekly performance.

Select Sector SPDRs allow investors to purchase the S&P 500 Index in pieces. The S&P 500 is an index composed of 500 stocks that has the largest market capitalization and are highly liquid.

Select Sector SPDRs allow investors to diversify investments in certain sectors or industry groups. This minimizes the impact of company-specific risk within an investment portfolio.



STOCKS TO WATCH

- As at the end of October 2023, the Jamaica Stock Exchange main market index closed at 318,787.67. This represented a decrease of M-o-m 2.52%, YTD (10.43%) and 12 month (8.30%).
- The market capitalization of the main market was \$1,610.72 million a decline of \$41.76 million or 2.53% at the end of October, relative to September 2023. The one-month advanced-to-decline ratio on the main market index in October was 15:33, with an average price depreciation of 2.49%.
- In October, the top three performing stocks were Wisynco Group Limited, Proven Group Limited and Eppley Limited. Conversely, the top three declining stocks for the same period were FirstRock Real Estate Investment Limited, Pulse Investment Limited and Palace Amusement (1921) Company Limited
- As at the end of October 2023, the Jamaica Stock Exchange junior market index closed at 3,862.87 This represented a decline of M-o-m 2.44%%, YTD (3.10%%) and 12 month (4.66%).
- The market capitalization of the junior market index declined to \$186,380.28 million (2.44%) at the end of October, relative to September 30, 2023. The one-month advanced-to-decline ratio on the junior market index for October was 17:27, with an average price depreciation of 2.57%.
- In October, the top three performing stocks on the junior market were Edufocal Limited, Mailpac Group Limited and Dolla Financial Services Limited. In contrast, the top three declining stocks for the same period were iCreate Limited, Paramount Trading and tTech Limited.
- The performance of equities is in comparison to the returns on other assets. The average rate on the BOJ 30-day Certificate of Deposit (CD) for the month of October was 9.53%. Meanwhile, foreign currency yielded a M-o-M return of 0.38%.



SOVEREIGN YIELD



The next auction of Government of Jamaica Treasury Bills is scheduled for Wednesday, 8th November 2023.

- For the month of September, U.S. inflation remained at 3.7% like the rate recorded in August. The pace of inflation continues to be above Federal Reserve's targeted rate of 2.0%. Of note, the US Central Bank announced its decision to maintain the target range for the federal interest rate at 5.25% to 5.50% on Wednesday. The US monetary committee's objectives are to achieve maximum employment and maintain inflation at a rate of 2.0% over the long term.
- The next meeting of the US Central Bank is scheduled for December 12-13, 2023, to determine the path of US interest rate with summary of economic projections.
- Locally, Jamaica's annual headline inflation rate from September 2022 to September 2023 cooled to 5.9%. This result is slightly below the upper band of the BOJ's upper band of 6.0%. The BOJ is scheduled to meet on November 21, 2023, to determine the local policy rate.
- Last week, the BOJ auctioned the 30-day Certificates of Deposit (CDs). At the end of the auction, the average yield was 9.64%, an increase of 7 basis points (bps) relative to the previous week's average yield of 9.57%. The total value of CDs offered during the week's auction increased to \$31.0 billion compared to the previous week's \$30.0 billion.
- New T-Bills are being offered in the market: 91D, 182D and 273D T-Bills with volumes of \$700M, \$800M and \$700M, respectively. The subscription date is November 8th whilst the settlement date is November 10, 2023. Their price and yields are to be determined by competitive bidding.
- The GOJ is floating a new sovereign bond on international markets. The offer is priced at a coupon of 9.625% and is seeking to raise about US\$297.4M which is greater than J\$46 billion in local currency. The new bond which matures in 2030, carries a higher interest rate than the old bonds being redeemed the 7.625% due 2025; the 9.250% due 2025 and the 6.750% due 2028. Additionally, the GOJ will Reopen FR 10.00% BIN Due 2037 on November 24, 2023.




- For the trading week ended November 3, 2023, the USD Weighted Average Selling Rate (WASR) closed at J\$157.18.
- The closing WASR represents a depreciation of 0.70% relative to the previous week.
- The WASR traded between J\$156.08 and \$157.18. Notwithstanding the depreciation, BOJ did not intervene in the market.
- The recent relative stability within the FX market has been disrupted.
- This marks the highest weighted average sell rate over the past fifty-two weeks. Consequently, the FX rate experienced the steepest weekly depreciation since February 2022 at \$158.03.
- YTD, the value of the Jamaican dollar (JMD) has depreciated by 3.37%, relative to an appreciation of 0.3% for the comparable period of 2022.
- Over the past 12 months the currency has depreciated by 1.66%.
- The market daily average volume sold, during the week, was US\$57.0 million, relative to an average of US\$49.24 million in the previous week.



- The National Housing Trust (NHT) has reported that the number of homeowners in default is on a downward trajectory.
- This announcement comes amidst the fact that the delinquencies are in the region of 14 per cent of its portfolio.
- As of September 30, NHT said its portfolio had 9,559 property mortgage loans in default.
- However, the outturn was an improvement on the 9,905 bad loans on its books in the corresponding period of September 2022.
- In total, 13.86 per cent of the mortgaged properties are in default.
- The agency however pointed out to the Financial Gleaner that the finding is 0.52 per cent less than the 14.37 per cent for the corresponding period in September 2022.
- Year to date, January to September, NHT put up 61 properties for auction, representing 0.01 per cent of the total number of mortgaged properties.
- Elsewhere in the Economy, the fisheries sector is making a substantial impact on the island's GDP.
- The National Fisheries Authority (NFA) reported that between April and June 2023, the fisheries contribution to Jamaica's agriculture sector grew by 16 per cent in 2022 against 2021, recording a 9.64 per cent contribution valued at \$17.7 billion. This was driven by an increase in aquaculture production.


