Overall Market activity resulted from trading in 121 stocks of which 39 advanced, 73 declined and 9 traded firms.


For the week ended October 06, 2023, the Composite Index advanced by 1.51 points (0.12%) to close at 1,211.14.


S&P 500

For the week ending September 29, 2023, the S&P 500 declined by 0.7%. Over the same period, the Dow Jones plummeted by 1.3%, whilst the Nasdaq advanced by 0.1%.

The graph below breakdown the performance of the Select Sector SPDR Exchange Traded Funds (ETFs) that represents the eleven sectors of the S&P 500 and their weekly performance.

Select Sector SPDRs allow investors to purchase the S&P 500 Index in pieces. The S&P 500 is an index composed of 500 stocks that has the largest market capitalization and are highly liquid.

Select Sector SPDRs allow investors to diversify investments in certain sectors or industry groups. This minimizes the impact of company-specific risk within an investment portfolio.





STOCKS TO WATCH

- As at the end of September 2023, the Jamaica Stock Exchange main market index closed at 327,042.43. This represented an increase of M-o-m 1.65%, YTD (8.11%) and 12 month (9.58%).
- The market capitalization of the main market was \$1,652.48 million an increase of \$33.03 million 2.04% at the end of September, relative to August 31, 2023. The one-month advanced-to-decline ratio on the main market index in September was 26:20, with an average price appreciation of 0.47%.
- In September, the top three performing stocks were General Accident Insurance Company LTD, Radio Jamaica Limited, and Guardian Holdings Limited. Conversely, the top three declining stocks for the same period were Mayberry Investments Limited, Palace Amusement (1921) Company LTD, and Key Insurance Company LTD.
- As at the end of September 2023, the Jamaica Stock Exchange junior market index closed at 3,959.34 This represented an increase of M-o-m 1.01%, YTD (0.68%%) and 12 month (6.39%).
- The market capitalization of the junior market index declined to \$191,034.62 million (1.30%) at the end of September, relative to August 31, 2023. The one-month advanced-to-decline ratio on the junior market index for July was 19:26, with an average price appreciation of 0.75%.
- In September, the top three performing stocks on the junior market were FosRich Company Limited, Caribbean Assurance Brokers LTD, and Caribbean Cream Limited. In contrast, the top three declining stocks for the same period were Main Event Entertainment Group LTD, CAC 2000 Limited, and Dolla Financial Services Limited.
- The performance of equities is in comparison to the returns on other assets. The average rate on the BOJ 30-day Certificate of Deposit (CD) for the month of September was 9.42%. Meanwhile, foreign currency yielded a M-o-M return of 0.04%.



SOVEREIGN YIELD





The next auction of Government of Jamaica Treasury Bills is scheduled for Wednesday, $11^{\rm th}$ October 2023.

- The inflation rate in the US remains elevated at 3.70%. Of note, the US Central Bank has decided to maintain the target range for the federal interest rate at 5.25% to 5.50%. The US monetary committee's objectives are to achieve maximum employment and maintain inflation at a rate of 2.0% over the long term. Maintaining interest rates is expected to tame inflation.
- Locally, Jamaica's annual headline inflation rate in August 2023 of 6.8% was above the outturn of 6.6% in July 2023. Several factors contributed to the moderate increase in inflation between May and August 2023, including rising agricultural prices, oil prices, and wage pressures. Notwithstanding, inflation is expected to gradually decline into the central bank's target range of 4.0% to 6.0% by the fourth quarter of 2023.
- Last week, the BOJ auctioned the 30-day Certificates of Deposit (CDs). At the end of the auction, the average yield was 9.47%, an increase of 25 basis points (bps) relative to the previous week's average yield of 9.22%. The total value of CDs offered during the week's auction amounted to J\$28 billion compared to J\$27 billion in the previous week.
- The government of Jamaica is scheduled to hold auctions for 3-month and 6-month Treasury Bill Tenders on October 11, 2023. Similarly, On October 10, 2023, the BOJ is scheduled to auction an 8.50% BOJ FR 2YR—CD 20231012. The planned issue of the FR 11.25% BIN due 2046 was cancelled.










FOREIGN EXCHANGE

- For the trading week ended October 6, 2023, the USD Weighted Average Selling Rate (WASR) closed at J\$155.47.
- The closing WASR remained unchanged at 0.00% relative to the previous week.
- Last week, the USD foreign exchange market exhibited limited volatility, maintaining a narrow trading range between \$155.43 and \$156.24.
- There was some demand pressure in the market. This was largely offset by BOJ intervention. The central bank sold US\$20 million on Monday at the rate of \$155.05 and US\$40 million on Thursday at the rate of \$155.23.
- In September, the net international reserve (NIR) was US\$4,716.57million, showing an increase from the NIR value of US\$4,392.10million recorded in August.
- YTD, the value of the Jamaican dollar (JMD) has depreciated by 2.25%, relative to an appreciation of 0.60% for the comparable period of 2022.
- Over the past 12 months the currency has depreciated by 0.86%.
- The market daily average volume sold, during the week, was US\$62.72M, relative to an average of US\$54.25M in the previous week.

MACRO- ECONOMIC PERFORMANCE

- In the June 2023 quarter, the balance of payments (BOP) current account is estimated to have achieved a surplus ranging from 0.0% to 1.0% of the Gross Domestic Product (GDP).
- This positive development is primarily attributed to enhancements in the trade and services sub-accounts, although it is partially counteracted by a decline in the current transfer's sub-account.
- For the fiscal year 2023/24, the current account (CA) is anticipated to deteriorate, projecting a surplus of 0.7% of GDP, in contrast to the 1.7% surplus recorded in FY2022/23.
- The augmentation in the merchandise trade balance is mainly due to heightened exports in the mining and quarrying sectors, as well as agriculture, coupled with reduced fuel imports.
- The service balance improvement is driven by increased revenue from travel and reduced expenditure in the transport sector.
- Projections indicate the sustainability of the current account over the medium term, with FY2023/24 to FY2024/25 foreseeing a deterioration to an average surplus ranging from 0.0% to 1.0% of GDP.
- In FY2025/26 to FY2028/29, the current account balance is predicted to decline further, albeit at a reduced rate, with an average deficit ranging between 0.3% to 2.0% of GDP.
- The current account balance is anticipated to maintain an average surplus of 2.6% of GDP during the three-year forecast period from FY2023/24 to FY2025/26.


